# HDA Annual Meeting

## Contract Terms and Conditions

### Terms of Payment

**Full payment is due with signed contract.** Table space will not be reserved or assigned without full payment. Contract received before **June 30th, 2025** are eligible for **EARLY BIRD** pricing. Contracts received after **July 1st, 2025** are subject to **STANDARD** pricing. Tables contracted within 15 days of the start of the meeting must be paid in full by credit card only. Checks are not accepted within this period.

### Contract Approval

All Exhibitor/Sponsor contracts are subject to approval by the HDA Annual Meeting Committee. The Committee may accept or reject any contract to exhibit in its sole discretion, and has full and final authority to interpret, amend or supplement these Guidelines, Rules and Regulations.

### Cancellation Deadline

Cancellations received prior to **Aug. 15, 2025** are eligible for a **50% refund**. Cancellations received after **Aug. 15, 2025** are **not eligible for refund**. All cancellations must be made in writing and sent to [membership@hdassoc.org](mailto:membership@hdassoc.org)

### Exhibitor Registration

Registration and name badge identification are required for every employee, representative, and attendee of the meeting. Exhibitors may register up to 2 personnel at no charge for each table space purchased. Additional personnel will be charged a fee of \$10 each. Each table is limited to 4 total personnel. All registrations must be submitted prior to the start of the meeting. The name badge issued at the time of registration must be worn at all times during the meeting. Exhibitors rendering badges to unauthorized persons shall forfeit their exhibit space without eligibility for a refund and future exhibition privileges.

### Assignment of Subletting

Exhibiting company shall use its table space solely and exclusively for the exhibition of material, equipment or services normally manufactured, distributed, or furnished by it in the regular course of its business, and for no other items or purposes of any kind. **The exhibitor shall not assign, sublet, license, or otherwise release, transfer, apportion, or dispose of its exhibit space, name badge or any part thereof. Any use of all or part of said space by or for any person, firm, or entity other than the exhibitor will cause the exhibitor and the person, firm, or entity to be asked to leave the meeting without a refund. Non-exhibiting companies are not allowed at any function or activity at the HDA Annual Meeting. Violators will be asked to exit the premises.**

### Insurance

Exhibiting company agrees to carry insurance for a single limit of not less than \$1,000,000 for its employees, agents, contractors, and representatives present at the HDA Annual Meeting in each of the following categories: Broad Form General Liability and Automobile Liability. The exhibitor agrees to provide Workers' Compensation Insurance providing benefits for the state of New York and Employers Liability of \$1000,000 per accident. An umbrella liability policy would be satisfactory provided all these areas are covered. The policy must name as additional insureds: The Hispanic Dental Association and the Sonesta White Plains Hotel. Exhibitor must provide a Certificate of Insurance showing the policy in effect through Sept. 20, 2025. EXHIBITORS MUST PROVIDE PROOF OF INSURANCE NO LATER THAN Aug. 30, 2025.

### Exhibit Limitations

The exhibitor shall conform to and comply with the following requirements:

- All displays must be confined within the limits of the table space and approved by the Annual Meeting Committee.
- Loud sounds speakers or sound interference are not permitted
- Helium balloons or combustible materials are not permitted.
- Empty crates must be removed from the exhibit area for proper storage. Storage of freight, cartons, excelsior, etc., within the table space is prohibited.
- Using outside contractors for the following services is prohibited: electrical, internet, telephone, table space cleaning, facility-affixed audio, lighting and structural rigging and parking.
- **Use of nitrogen tanks within table space is subject to prior approval by show management.** Equipment in operation must provide protection against any damage to the Marriott Harbor Beach Resort or any HDA Annual Meeting vendors, etc.

### General Exhibit Regulations

The HDA has developed these regulations to provide a well-balanced, well-regulated, attractive and successful event. No exceptions to these regulations will be permitted. The HDA reserves the right to enforce strict compliance with these Exhibit Regulations.

### Indemnification and Liability

The exhibitor assumes the entire responsibility and liability for losses, damages and claims arising from personal injury, injury or damage to exhibitor's displays, equipment and other property brought upon the hotel premises. The exhibitor shall indemnify and hold harmless the HDA, exhibit service contractor, the hotel, its agents and employees from any and all losses, damages and claims. The HDA will not insure or indemnify exhibitors against theft or loss of any kind. This is an open-booth show and it is the responsibility of each exhibitor to safeguard its exhibits and merchandise. It is the exhibitor's responsibility to secure their exhibit and other property when security guards are not provided.

NOTE: Absolutely no children under age 18 are allowed in the exhibit hall during exhibitor set-up or breakdown hours.

### Default

The HDA reserves the right to cancel this contract if an exhibitor displays, sells a product which is not authorized by the meeting committee after being notified to discontinue such display or sale; or breaks any other regulation. In such event, all payments previously made on this contract are non-refundable. The HDA shall be released from all claims for damages, loss, costs, or expenses sustained or incurred by the exhibitor by reason of such cancellation.

### Rules and Regulations

The HDA reserves the right to make such additional rules and regulations as it deems proper to cover the conduct and promote the success of the meeting. The breach of any such rule and regulation by the exhibitor, after being notified in writing thereof, shall be grounds for dismissal from the meeting with no recourse for refund or any claims for any loss or damages.

### Security

Security will be provided in the exhibit area. However, neither the HDA or the Marriott Harbor Beach Resort shall be held responsible for any loss or damage to equipment, materials or products within the exhibit area. It is the responsibility of the exhibitor to provide for any damages or losses of any kind the equipment, materials or products on display.

### Miscellaneous

On all matters not herein covered, or on any differences, final decisions are subject to the judgement of the HDA. Additionally, factors beyond our control (pandemics, inclement weather, etc) could impact the layout of the exhibit area. Should this occur, the HDA Annual Meeting Committee reserves the right to modify the exhibit area layout accordingly.
